## 1 Scope

This European Standard specifies the properties of acrylonitrile-butadiene rubber (NBR) <sup>1)</sup>, mineral oil resistant, hardness 60 IRHD, for aerospace applications.

## 3 Application of the material

### 3.1 General

The suitability of the material for a specific application shall be determined by complementary tests carried out on the finished product as the properties specified in this standard are obtained from standard test specimens.

### 3.2 Typical use

For applications where resistance to petroleum based hydraulic fluids and lubricants is required.

### 3.3 Temperature range

— Continuous service : from – 40 °C to 120 °C;

— Intermittent service : from – 40 °C to 150 °C.

## 4 Properties

See Table 1 and Table 2 according to EN 3207.

For qualification, all tests shall be performed.

For batch acceptance, the tests identified with footnote "a" in Table 1 and Table 2 shall be performed.
