1 Scope

This European Standard specifies the properties of acrylonitrile-butadiene rubber (NBR) ¹⁾, fuel and synthetic oil resistant, hardness 90 IRHD, for aerospace applications.

3 Application of the material

3.1 General

The suitability of the material for a specific application shall be determined by complementary tests carried out on the finished product as the properties specified in this standard are obtained from standard test specimens.

3.2 Typical use

For applications where resistance to petroleum based fuels and diester based lubricants is required.

3.3 Temperature range

— Continuous service : from – 40 °C to 120 °C;

— Intermittent service : from – 40 °C to 150 °C.

4 Properties

See Table 1 and Table 2 according to EN 3207.

For qualification, all tests shall be performed.

For batch acceptance, the tests identified with footnote "a" in Table 1 and Table 2 shall be performed.
