# Introduction

Understanding the legal form of an entity is an important component of financial services transactions. Entering into a business relationship requires distinguishing the type of entity that is being transacted with. Parties (and their organizational structure) involved in financial transactions need to be identified within these transactions. This is achieved while the support for straight through processing (STP) is still maintained. Standardization of the legal or organizational construct will aid flexibility and provide greater understanding of exposure to risk and access to capital.

Regulators and market participants have recognized the need to identify entity legal forms, both nationally and consistently across the global markets and have asked for a standard to be developed to meet this need.

This document fulfils the need for the identification of entity legal forms in a structured way in order, among other things, for entities to be classified according to the nature of their legal constitution. Its key provisions are that it:

- enables unique identification globally of entity legal forms;
- defines an ELF scheme that is reliable and an ELF Code that is persistent;
- defines an ELF code that contains no embedded intelligence regarding the identification of the entity legal form to which it applies;
- leverages the expertise of ISO/TC 68 in defining and maintaining identifier standards;
- defines an ELF scheme that is extensible and free from limitation on use and redistribution.

# 1 Scope

This document specifies the elements of an unambiguous scheme to identify the distinct entity legal forms in a jurisdiction. Its aim is to enable legal forms within jurisdictions to be codified and thus facilitate the classification of legal entities according to their legal form.

It is not the purpose of the document to give the comparison or alignment of entity legal forms across different jurisdictions, so as not to limit its usage and relevance.

#### entity legal form

type of entity that an organization is considered to be within the legal or regulatory system under which it is formed

Note 1 to entry: It includes, but is not limited to, both unincorporated forms and incorporated forms.

#### 3.2

#### legal entity

legal person or structure that is organized under the laws of any jurisdiction

EXAMPLE Examples of eligible entities include, without limitation:

- all financial intermediaries;
- banks and finance companies;
- all entities that issue equity, debt or other securities for other capital structures;

- all entities listed on an exchange;
- all entities that trade stock or debt, investment vehicles, including mutual funds, pension funds and alternative investment vehicles constituted as corporate entities or collective investment agreements (including umbrella funds, as well as funds under an umbrella structure, hedge funds, private equity funds, etc.);
- all entities under the purview of a financial regulator and their affiliates, subsidiaries and holding companies;
- counterparties to financial transactions.

# supranational

governmental or non-governmental entity that is established by international law or treaty or incorporated at an international level

## country of formation

country or collection of countries (e.g. European Union) of the legal or regulatory system under which the *Entity Legal Form* (3.1) is formed, as represented in ISO 3166-1 alpha 2

#### 3.5

#### iurisdiction of formation

sub-division of a country of the legal or regulatory system under which the *Entity Legal Form* (3.1) is formed, as represented in ISO 3166-2

# 4 ELF Code structure

The ELF Code is an alphanumeric code of four characters from the Basic Latin character set.

Alphabetic characters are uppercase letters A to Z, without accents (e.g.  $\grave{A}$ ,  $\acute{E}$ ,  $\ddot{O}$ ,  $\~{N}$ ) and excluding "special" characters such as blanks, separators or punctuation.

Numeric characters are integers within the range 0 to 9.

Codes comprised of solely numeric characters will be reserved and not assigned by the maintenance agency.

An ELF code contains no embedded intelligence regarding the identification of the entity legal form to which it applies. Because this document does not document the comparison or alignment of entity legal forms across different countries or jurisdictions, a unique ELF Code will be assigned for every entity legal form identified using this document.

EXAMPLE A Limited Liability Company in one country or jurisdiction may be assigned an ELF Code of D4R1 whereas an equivalent or similarly named legal form in another country/jurisdiction may be assigned an ELF Code S3E3.

#### 5 ELF data record

The ELF data record shall be composed of the following minimum data attributes.

- Entity legal form name, formed from the following components and present for all relevant official local languages of the country and/or jurisdiction of formation:
  - local name: name of the entity legal form in its local language and character set;
  - language: language used in the local name, as represented in ISO 639-1;
  - transliterated name: the local name transliterated into basic Latin using the relevant standard as per ISO Standards Catalogue 01.140.10;

- abbreviations: commonly used abbreviations such as acronyms and truncations.
- Country of formation: As defined in 3.4, including EU or XZ for supranationals.
- Jurisdiction of formation: For use where separate legal jurisdictions exist for the formation of an entity within a country, as represented in ISO 3166-2, where applicable, or otherwise full name in basic Latin.
- Date created: Date ELF record created, as represented in ISO 8601.
- ELF status: Whether the ELF is active or inactive (i.e. the legislation has been repealed or superseded).
- Modification date: Date ELF record was modified, as represented in ISO 8601.
- Modification reason: Reason ELF record was modified.

The ELF Data Record shall be structured as follows in relation to the minimum set of data attributes.
