h) to j) See ISO 294-1:1996, subclause 4.1.1.4, items h) to j).

by

h) Ejector pins, if used, shall be located outside the test area, i.e. outside the 50-mm-square central section of the plate specimen.

i) to j) See ISO 294-1:1996, subclause 4.1.1.4, items i) to j).

Page 5, Subclause 5.2, second sentence

Replace by the following sentence:

For type D1 and D2 ISO moulds, it is recommended that the injection velocity v_1 chosen be comparable to that used for the type A ISO mould.
