#### **FOREWORD**

ISO (the International Organization for Standardization) is a worldwide federation of national standards institutes (ISO member bodies). The work of developing International Standards is carried out through ISO technical committees. Every member body interested in a subject for which a technical committee has been set up has the right to be represented on that committee. International Standard ISO 1870 therefore replaces ISO Recommendation R 1870-1970, to which it is technically identical.

# Chloroform for industrial use - List of methods of test

#### 1 SCOPE AND FIELD OF APPLICATION

This International Standard specifies methods of test for chloroform (trichloromethane) (CHCl<sub>3</sub>) for industrial use.

#### 2 REFERENCES

ISO 758, Liquid chemical products for industrial use -Determination of density at 20 °C.

ISO 760. Determination of water - Karl Fischer method.

ISO/R 918. Test method for distillation (distillation yield and distillation range).

ISO 1393, Liquid halogenated hydrocarbons for industrial use - Determination of acidity - Titrimetric method.

ISO 2209, Liquid halogenated hydrocarbons for industrial use - Sampling.

ISO 2210, Liquid halogenated hydrocarbons for industrial use - Determination of residue on evaporation.

ISO 2211, Liquid halogenated hydrocarbons for industrial use - Measurement of colour in Hazen units (platinumcobalt scale).

#### 3 SAMPLING

Prepare the laboratory sample in accordance with ISO 2209.

NOTE - The sampling and handling of samples shall be carried out as quickly as possible and generally in such a way that the contact of the sample with air and light is reduced to a minimum. The quantities taken either for analysis or for storage as reference samples shall be preserved in dark-coloured, clean and dry containers with a ground glass stopper.

# 4 DETERMINATION OF DISTILLATION CHARAC-**TERISTICS**

Use the method specified in ISO/R 918, subject to the following details and modifications appropriate for chloroform.

# 4.1 Principle (See clause 2 in ISO/R 918)

This determination indicates either the temperatures

corresponding to the collection of each of two volumes of distillate,  $V_0$  and  $V_1$ , or the difference between these two volumes. These two volumes will be indicated in the specification for chloroform agreed between the interested parties.

#### 4.2 Thermometer (See 3.2 in ISO/R 918)

Range: 59 to 71 °C or other suitable range (for example, 48 to 102 °C).

NOTE - Avoid exposure of the thermometer to sunlight during the test.

#### 4.3 Distillation rate (See 6.2 in ISO/R 918)

4 to 5 ml/min.

#### 4.4 Temperature correction (See 5.2 and 7.2 in ISO/R 918)

The thermometer correction, which is necessary only when the purpose of the determination is to ascertain the two temperatures corresponding to the volumes of distillate  $V_0$ and  $V_1$ , is equal to

or 
$$0,040 (760 - p_1)$$
 °C  $0,030 (1 013 - p_2)$  °C

where

p<sub>1</sub> is the barometric pressure in millimetres of mercury;

p<sub>2</sub> is the barometric pressure in kilopascals.\*

This correction shall be added to the observed temperatures.

# 5 DETERMINATION OF DENSITY AT 20 °C

Use the method specified in ISO 758.

## **6 DETERMINATION OF RESIDUE ON EVAPORATION**

Use the method specified in ISO 2210.

#### 7 DETERMINATION OF WATER CONTENT

Use one of the methods specified in ISO 760. In the case of water content of less than 10 ppm, use a 500 ml titration vessel and a 200 ml test portion and take suitable percautions.

## **8 MEASUREMENT OF COLOUR**

Use the method specified in ISO 2211.

#### 9 DETERMINATION OF ACIDITY

Use the method specified in ISO 1393.

#### 10 TEST REPORT

The test report for each determination shall include the following particulars:

- a) the reference of the method used;
- b) the results and the method of expression used;
- c) any unusual features noted during the determination;
- d) any operation not included in this International Standard or in the documents to which reference is made, or regarded as optional.
