## AMENDMENT 1

*Page 7, Clause 3*

Add the following terms and definitions.

**3.47**

**daytime running lamp**

lamp facing in the forward direction used to make the vehicle more easily visible when driving during daytime

**3.48**

**lamp equipped with replaceable light source**

lamp whose light source(s) can be replaced by an equivalent light source(s) of the same type

**3.49**

**lamp equipped with non-replaceable light source**

lamp whose light source(s), designed to be permanently fitted, cannot be replaced without damaging the source module

**3.50**

**distributed lighting system**

system that transmits light from a remote source to one or more lighting functions
