Page 1, Normative references

Replace the reference to ISO 6533:2001 with the following:

ISO 6533:—¹⁾, *Forestry machinery — Portable chain-saw front hand-guard — Dimensions and clearances*

Add the footnote:

1) To be published. (Revision of ISO 6533:2001)

Page 1, 3.1

Replace the second and third paragraphs with the following text:

The grip area shall be determined as described below. The length of the grip area shall be limited either by obstructions of the chainsaw or by the reference points X_0 and X_1 , shown in Figure 2.

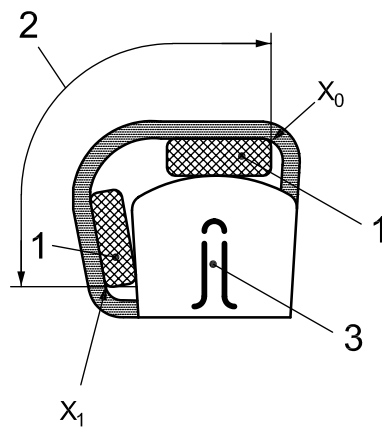
Reference point X_0 shall be determined according to ISO 6533.

Reference point X_1 shall be determined by using a type A gauge (according to ISO 6533:—) furthest down to the left side, as shown in Figure 2. The gauge shall be kept parallel with and directly to the side of the centreline of the front handle, and in contact with the handle and moved until it comes into contact with the housing of the machine.
