#### Introduction

This Technical Corrigendum applies to ISO 10303-503:2000.

The purpose of the modifications to the text of ISO 10303-503:2000 is to amend EXPRESS definitions likely to cause unduly cumbersome representations of 2D line segments and to replace the object identifier for the document and the applicable schema.

#### Modifications to the text of ISO 10303-503:2000

Clause 2 p.1 The first normative reference has been withdrawn and replaced by a later edition. Delete the first normative reference (ISO/IEC 8824-1) and replace with:

ISO/IEC 8824-1:2002, Information Technology — Abstract Syntax Notation One (ASN.1) — Part 1: Specification of basic notation

#### Clause 4.3, p. 4

The entity geometrically\_bounded\_2d\_wireframe\_representation as originally defined contains a constraint which required all polyline instances to contain more than 2 points. For the purpose of representing simple 2D drawings this constraint is undesirable.

Delete the description of WR8 from the list of formal propositions.

Remove the existing EXPRESS definition from clause 4.3 and replace it with the following definition.

#### Introduction

ISO 10303 is an International Standard for the computer-interpretable representation and exchange of product data. The objective is to provide a neutral mechanism capable of describing product data throughout the life cycle of a product, independent from any particular system. The nature of this description makes it suitable not only for neutral file exchange, but also as a basis for implementing and sharing product databases and archiving.

This International Standard is organized as a series of parts, each published separately. The parts of ISO 10303 fall into one of the following series: description methods, integrated resources, application interpreted constructs, application protocols, abstract test suites, implementation methods, and conformance testing. The series are described in ISO 10303-1. This part of ISO 10303 is a member of the application interpreted constructs series.

An application interpreted construct (AIC) provides a logical grouping of interpreted constructs that supports a specific functionality for the usage of product data across multiple application contexts. An interpreted construct is a common interpretation of the integrated resources that supports shared information requirements among application protocols.

This document specifies the application interpreted construct for the description of a geometric shape by means of two-dimensional geometrically bounded wireframe models.

### 1 Scope

This part of ISO 10303 specifies the interpretation of the integrated resources to satisfy requirements for the representation of the product shape using two-dimensional geometrically bounded wireframe models.

The following are within the scope of this part of ISO 10303:

- points defined in a two-dimensional coordinate space;
- curves defined in a two-dimensional coordinate space that are trimmed by points and curves:
- curves defined in a two-dimensional coordinate space that are self-intersecting;
- the representation of a single wireframe model or an assembly of wireframe models.

The following are outside the scope of this part of ISO 10303:

- geometry defined in a three-dimensional coordinate space;
- curves that are not trimmed and that are not self-intersecting.

#### 4 EXPRESS short listing

#### 4.1 Introduction

This part of ISO 10303 provides the geometric structures to represent two-dimensional shapes and is represented by the entity geometrically\_bounded\_2d\_wireframe\_representation, that is a shape\_representation (see ISO 10303-41).

#### 4.2 Fundamental concepts and assumptions

This wireframe representation of shape is based on two-dimensional geometry where unbounded curves are trimmed by points. The shapes represented by the geometrically\_bounded\_2d\_wireframe\_-representation are those requiring only bounded curves.

## 4.3 aic\_geometrically\_bounded\_2d\_wireframe entity definition: geometrically\_bounded\_2d\_wireframe\_representation

A geometrically\_bounded\_2d\_wireframe\_representation is a shape\_representation that represents the shape of a product by two-dimensional wireframe geometry without topology. These representations are formed by the use of two-dimensional points and curves only. All unbounded curves shall be explicitly trimmed unless they are closed. The geometric entities that are used to support the definition of another geometric entity shall not exist themselves in the elements set of a geometric\_curve\_set.

EXAMPLE 1 - A circular arc is to be used to define the corner radius on a part that is being represented using a **geometrically\_bounded\_2d\_wireframe\_representation**. The representation of that arc is a **trimmed\_curve** that references a circle as its **basis\_curve**.

NOTE - An application protocol that uses this AIC may ensure that the **shape\_representation** entity is instantiated as an **geometrically\_bounded\_2d\_wireframe\_representation**.

#### Formal propositions:

WR1: The geometrically\_bounded\_2d\_wireframe\_representation shall have a coordinate\_space\_dimension equal to two.

WR2: The items in a geometrically\_bounded\_2d\_wireframe\_representation shall be geometric\_curve\_set, axis2\_placement\_2d, or mapped\_item.

WR3: The items of a geometrically\_bounded\_2d\_wireframe\_representation shall include at least one mapped\_item or one geometric\_curve\_set.

WR4: If there is a mapped\_item in a geometrically\_bounded\_2d\_wireframe\_representation, the source of the mapped\_item shall be a geometrically\_bounded\_2d\_wireframe\_representation.

WR5: Every element in a geometric\_curve\_set shall be either a b\_spline\_curve, circle, composite\_curve, ellipse, offset\_curve\_2d, point, polyline, or trimmed\_curve.

WR6: Every offset\_curve in a geometric\_curve\_set of a geometrically\_bounded\_2d\_wireframe\_representation shall have a basis curve that is a polyline, b\_spline\_curve, ellipse, or circle. Every curve\_replica in a geometric\_curve\_set of a geometrically\_bounded\_2d\_wireframe\_representation shall have a parent curve that is a polyline, b\_spline\_curve, ellipse, or circle. Every composite\_curve in a geometric\_curve\_set of a geometrically\_bounded\_2d\_wireframe\_representation shall have segments that can be polyline, b\_spline\_curve, ellipse, or circle. Every trimmed\_curve in a geometric\_curve\_set of a geometrically\_bounded\_2d\_wireframe\_representation shall have a basis curve that is either a polyline, b\_spline-\_curve, ellipse, circle,line, parabola, or hyperbola.

WR7: Every point in the elements of a geometric\_curve\_set of a geometrically\_bounded\_2d\_wireframe\_representation shall be either a cartesian\_point or a point\_on\_curve.

WR8: Every polyline in the elements of a geometric\_curve\_set of a geometrically\_bounded\_2d\_wireframe\_representation shall contain more than two distinct points.

## ${\bf 4.4~aic\_geometrically\_bounded\_2d\_wireframe~function~definition:valid\_basis\_-curve\_in\_2d\_wireframe}$

The valid\_basis\_curve\_in\_2d\_wireframe function determines whether or not an input curve is valid for use as the basis of another curve in representing a shape defined by a two dimen-sional geometrically bounded wireframe. It is concerned with the correct use of bounded curves to serve as reference curves for offset\_curve, curve\_replica, and composite\_curve. If an unbounded curve such as a parabola or hyperbola is used, it must be trimmed. The function is recursive in its structure in order to check to the necessary levels.



 $Figure~C.1-aic\_geometrically\_bounded\_2d\_wire frame~-~EXPRESS-G$ diagram 1 of 5




Figure C.2 - aic\_geometrically\_bounded\_2d\_wireframe - EXPRESS-G diagram 2 of 5




Figure C.3 - aic\_geometrically\_bounded\_2d\_wireframe - EXPRESS-G diagram 3 of 5




Figure C.4 - aic\_geometrically\_bounded\_2d\_wireframe - EXPRESS-G diagram 4 of 5




Figure C.5 - aic\_geometrically\_bounded\_2d\_wireframe - EXPRESS-G diagram 5 of 5
