The colour coding shown in Table 3 should be used for a reduced set of Gr-type periodontal curettes. The colour coding is at the discretion of the manufacturer.

Table 3 — Colour coding for periodontal curettes

Type	Colour coding	Area
Gr 5 and Gr 6	Yellow	Anterior/premolar teeth
Gr 7 and Gr 8	Green	Molar and premolar teeth, buccal and lingual/palatal
Gr 11 and Gr 12	Red/orange	Molar and premolar teeth, mesial, furcations
Gr 13 and Gr 14	Blue	Molar and premolar teeth, distal, furcations
