Requirements and categorization for actuators

1 Scope

This part of ISO 14451 specifies the types and order of tests to be applied to the actuators and sets out the associated acceptance criteria and means of categorization.

This part of ISO 14451 applies to type tests.

This part of ISO 14451 is not applicable to articles conaining military explosives or commercial blasting agents except for black powder or flash composition.

3 Terms and definitions

For the purposes of this document, the terms and deifinitions given in ISO 14451-1 apply.

4 Requirements and acceptance criteria

4.1 General

Actuators shall meet the requirements specified in 4.2 to 4.8, taking into account the test matrix of Clause 5.

4.2 Verification of design and documentation

Documentation shall be complete as specified in ISO 14451-2:2013, 4.1.

4.3 Drop test

4.3.1 Requirements

Actuators shall be tested as specified in ISO 14451-2:2013, 4.2.

4.3.2 Acceptance criteria

No ignition of the actuator shall occur.

No spill out of the pyrotechnic composition from the actuator shall occur.

4.4 Vibration and temperature test

4.4.1 Requirements

Actuators shall be tested as specified in ISO 14451-2:2013, 4.3.

If all gas generators/igniters contained in the actuator are already successfully tested according to ISO 14451-4:2013, 4.4 or according to ISO 14451-8:2013, 4.3, the vibration and temperature test should be considered passed for the actuator as well.

4.4.2 Acceptance criteria

No ignition of the actuator shall occur.

No spill out of the pyrotechnic composition from the actuator shall occur.

4.5 Thermal humidity cycling test

4.5.1 Requirements

Actuators shall be tested as specified in ISO 14451-2:2013, 4.4.

If all gas generators/igniters contained in the actuator are already successfully tested according to ISO 14451-4:2013, 4.5 or according to ISO 14451-8:2013, 4.4, the thermal humidity cycling test should be considered passed for the actuator as well.

4.5.2 Acceptance criteria

No ignition of the actuator shall occur.

4.6 Electrostatic discharge (ESD) test

4.6.1 Requirements

Actuators shall be tested as specified in ISO 14451-2:2013, 4.5.

If all igniters contained in the actuator are already successfully tested according to ISO 14451-8:2013, 4.5, the ESD test should be considered passed for the actuator as well.

4.6.2 Acceptance criteria

No ignition of the actuator shall occur.

4.7 Fire test

4.7.1 Requirements

Actuators shall be tested as specified in ISO 14451-2:2013, 4.6 with the following heating rate and in a position that can be maintained without any fixation, considering the function, the shape and the connecting wire. This position shall be described in the technical documentation.

— **Heating rate**: 80K/min.

The number of burners shall be adequate to the dimensions of the actuator to completely engulf the actuator by the flames.

4.7.2 Acceptance criteria

Only foreseeable fragmentation or foreseeable opening of the actuator shall occur.

4.8 Functioning test

4.8.1 Requirements

Actuators shall be tested as specified in ISO 14451-2:2013, 4.9 in a position that can be maintained without any fixation, considering the function, the shape and the connecting wire. This position shall be described in the technical documentation.

When multi-stage actuators are tested, the delay between ignition of stage 1 and the following stages shall be 5 ms or in accordance with the product specification or requirements.

4.8.2 Acceptance criteria

The actuator shall show the intended behaviour corresponding to the intended process of fragmentation or opening.

Test matrix 5

Table 1 shows a test matrix which summarizes all tests in an overview. Test samples have been numbered from 1 to 10 for easier reference. The roman numbers in the Table indicate in which sequence the same sample will undergo different examinations.

6 Categorization

- **6.1** Actuators are categorized as follows:
- Category P1: Actuators that present a low hazard;
- Category P2: Actuators that are intended for handling or use only by persons with specialist knowledge.
- **6.2** The assignment to P1 or P2 of the actuator is done according to the following criteria when tested under functioning test (see 4.8):
- P1 criterion: The distance from the initial location to the first impact on the ground of the actuator or any fragment shall be not more than 15 m.
- P2 criterion: If P1 criterion is not fulfilled.
